A work session preceded the meeting to discuss all current projects. The Mayor and Council reviewed the previous Comprehensive Plan and discussed changes to the upcoming Habersham County Comprehensive Plan. Officials discussed upcoming events.

Mayor Turner also thanked the Council and the employees for their hard work and support in making the Alto Community Tree Lighting such a successful event.
